### **Instruction for Author**

Manuscripts must be prepared using accepted word-processing software, and all parts must be double-spaced. All pages must be numbered consecutively starting with the title page and including tables and figures. Lines in the abstract and text should be numbered consecutively from beginning to end. Do not put line numbers on pages with tables or figures. The Browallia New font, in a size of 16 points must be used. The Journal requires authors to stay within 6000 words or 15 pages limit, not including references, tables, and figures. Page layout of manuscript must be set with A4 size as following:

Top 1.0 inch	Bottom 0.8 inch
Left 1.25 inch	Right 0.8 inch

The various sections of the manuscript should be assembled in the following sequence:

- 1. Title and Authorship:** Give first name, last name and the complete mailing address of all institutions where work was conducted and identify the affiliation of each author. If the current address of an author is different, include it in a footnote on the title page. Provide the telephone number and e-mail address of corresponding author also.
- 2. Abstract:** The abstract should be a clear, concise (250 words), one-paragraph summary, informative rather than descriptive, giving scope and purpose, experimental approach, significant results, and major conclusions.
- 3. Keywords:** Provide significant 3-5 keywords
- 4. Introduction:** State the objectives of the work and provide an adequate background, avoiding a detailed literature survey or a summary of the results. This section may include a theory and a Calculation representing a practical development from a theoretical basis.
- 5. Material and methods:** Provide sufficient detail to allow the work to be reproduced. Methods already published should be indicated by a reference: only relevant modifications should be described.
- 6. Results and Discussion:** should be clear and concise. This should explore the significance of the results of the work. Avoid extensive citations and discussion of published literature.

**7. Conclusions:** The main conclusions of the study may be presented in a short Conclusions section, which may stand alone or form a subsection of a Discussion or Results and Discussion section

**8. Acknowledgment:** Include essential credits but hold to an absolute minimum. Omit academic and social titles Acknowledgment of financial support of the work can be included here.

**9. References:** All publications cited in the text should be presented in a list of references following the text of the manuscript. The manuscript should be carefully checked to ensure that the spelling of authors' names and dates are exactly the same in the text as in the reference list. All citations in text should refer to:

1. Single author: Seesuriyachan (2012) or (Seesuriyachan, 2012)
2. Two authors: Seesuriyachan and Phimolsiripol (2012) or (Seesuriyachan and Phimolsiripol, 2012)
3. Three or more authors: Seesuriyachan et al. (2012) or (Seesuriyachan et al., 2012)

Citations may be made directly (or parenthetically). Groups of references should be listed first alphabetically, then chronologically. Examples: "as demonstrated (Allan, 1996a, 1996b, 1999); Allan and Jones, 1995). Kramer et al. (2000) have recently shown...."

The list of references should be arranged alphabetically by authors' names, then further sorted chronologically if necessary. More than once reference from the same author(s) in the same year must be identified by the letters "a", "b", "c" etc., placed after the year of publication.

**References should be given in the following form:**

Thomson, F. M. 1984. Storage of particulate solids. In M. E. Fayed and L. Otten (Eds.). Handbook of powder science and technology (pp. 365-463). Van Nostrand Reinhold, New York.

Black, A.; White, B. Page title. URL (<http://etc.>) (most recent access date).

**Tables and Artwork:** Number tables consecutively in accordance with their appearance in the text. Place footnotes to tables below the table body and indicate them with superscript lowercase letters. Avoid vertical rules. Be sparing in the use of tables and ensure that the data presented in tables do not duplicate results described elsewhere in the article.

**Subdivision - numbered sections:** Divide your article into clearly defined and numbered sections. Subsections should be numbered 1.1 (then 1.1.1, 1.1.2, ...), 1.2, etc. (the abstract is not included in section numbering). Use this numbering also for internal cross-referencing: do not just refer to "the text". Any subsection may be given a brief heading. Each heading should appear on its own separate line.

**Referee:** Please submit, with the manuscript, the names, addresses and e-mail addresses of 3 potential referees. Note that the editor retains the sole right to decide whether or not the suggested reviewers are used. It is expected that authors who publish in the *Food and Applied Bioscience* will be asked to review future manuscripts submitted to the journal
